Village of Black River Board of Trustees Regular Meeting October 5, 2020



Mayor Decillis called the meeting to order and led the Pledge of Allegiance at 6:00 p.m.

A motion was made by Trustee Dishaw, seconded by Trustee McCullouch to approve the minutes of the 9/14/20 regular meeting minutes. The motion was carried.

<u>Police Department Report:</u> Police Chief Wood stated that he is the liaison between Jefferson County and the village police departments for the coalition for police reform policies. He stated that the Stop DWI Program has offered to reimburse the village \$1,000 for police coverage on specific days and times.

Mayor Decillis opened the public hearing at 6:05 p.m. for the sewer rate increase from \$276 per EDU to \$283 per EDU.

The board discussed property maintenance solutions. Trustee McCullouch stated that he would like to ask Code Enforcement Officer James Holland for some options to address property maintenance issues.

Superintendent's Report: Superintendent Williams stated that the lead and copper sampling is complete. He stated that he picked up the used plow, vehicles were undercoated and Joe Paige will be attending water school. Superintendent Williams discussed the vehicle use policy that states that vehicles must be left on premises at the end of a shift. He stated that he would like to be able to bring a vehicle home on nights that there is inclement weather because now he drives his own truck around to check the streets. The board agreed to look at some wording to amend the policy. Superintendent Williams stated that the Department of Transportation uses the break room and rest room at the village garage when they load their trucks with salt each year. He stated that due to COVID 19 he would like to prohibit access to those spaces because it would be difficult to track who is in the building and provide around the clock sanitization.

<u>Clerk-Treasurer's Report:</u> Clerk-Treasurer Williams stated that Jefferson County has contracted with a company to clean the municipal building before and after the election. She stated that since the regularly scheduled meeting is the night before the election is might make sense to move the meeting. The board agreed to hold the next regular meeting on November 9<sup>th</sup>.

Mayor Decillis stated that he has spoken with Logan Eddy from the Town of Rutland regarding the Rutland water district and that he would like to schedule a meeting with two Village and Town board members. It was agreed that Trustees McCullouch and Lake would attend the meeting.

<u>Public Comment:</u> Sean Hennessey was present to discuss parking for his proposed apartments and business at 102 Maple St. He noted some communities that share municipal parking with businesses. Mr. Hennessey presented his plan which showed his proposed business utilizing the village owned half of the parking lot that is adjacent to his building. Mr. Hennessey agreed to provide snow removal and maintenance in exchange for the use.

This letter is in reference to the above referred address and parcel number and complaints that the Village has received regarding the property.

By receipt of this letter I must inform you that you are in violation Village of Black River Code, section 128-5. A and 128-5. F. The following violations exist at the property.

Garbage on the property is not in appropriate receptacles, resulting in the garbage blowing onto neighboring properties and into the street. All garbage must be in appropriate receptacles and disposed of on at least a biweekly basis. (See attached photo)

This is a violation of the Village of Black River Code and you are hereby ordered to take corrective action immediately upon receipt of this letter. Failure on your part to correct the violations will result in the Village seeking legal action in your name in a court of competent jurisdiction. Penalties for each of these violations are fines of up to \$250 or by imprisonment of not more than 15 days. Each week of continued violation may result in additional fines or imprisonment.


