

Village of Black River Board of Trustees October 2, 2023 Regular Meeting



Mayor Dishaw called the regular meeting to order at 6:00 p.m.

A motion was made by Trustee Decillis, seconded by Trustee Proven to approve the minutes of the 9/11/23 regular meeting. The motion was carried.

Mayor Dishaw opened the public hearings regarding the Rt. 3 Sewer Budget and the Water Use Law amendment at 6:03 p.m.

<u>Clerk's Report:</u> Clerk-Treasurer Williams stated that she had received a call from a company that is interested in purchasing the village's cell tower lease. The board asked Clerk-Treasurer Williams to get the amount that the company would offer and they will discuss it further.

Superintendent's Report: Superintendent Williams stated that there were only three meters that did not read, West Remington St. has been paved, cuts in the roads have been blacktopped, the NYS Dept. of Health reviewed the lead and copper results and determined that they were below the legal limit, they installed a new water line on Maple St., there has been no response from Rutland regarding adding houses to the water system, DANC said that they have 540 meters on the system, he tracked 147 man hours that the DPW worked on water during the month. He stated that Blair Supply is closing and that they usually rent a tap machine there when needed. He stated that they are selling their surplus equipment and the village could buy a tapping machine for \$1,800. He stated that he would not be purchasing a metering pump for \$1,700 that he had requested in the budget.

A motion was made by Trustee Decillis, seconded by Trustee Lake to approve the purchase of the tap machine for \$1,800. The motion was carried.

A motion was made by Trustee Proven, seconded by Mayor Dishaw to close the public hearings at 6:35 p.m. The motion was carried.

Dear Frank:

We are in the process of reviewing, updating, and modifying the solar energy laws that we have in place. In our meeting last month, we were reviewing the various zones to see what the maximum amount of each landowner's property could be covered one of our board members discovered that in the A-1 two family dwelling there was no maximum amount of coverage and that the other zones all had a maximum coverage of 30 percent. This discrepancy means that the lot owner in this particular zone would have an unlimited amount of coverage on their lots. In this case each lot owner in this zone could fill their property with solar panels, for example where other zones are limited to 30 percent coverage.

On this discovery, at our regular meeting of the Black River Planning Board last month, we passed a motion to propose to the Village Board recommending that a maximum of 30 percent ground cover be added to the code book for our A-1 two family dwellings zone.

This action would make this property zone lot coverage limit equalized with the other zones in our laws. Please feel free to contact me at any time with questions on this.

My name is Meghan Hernandez. My husband Luke Hernandez and I reside at 127 Rodgers Rd with our children.


Recently, Mr. Benjamen Azah, the owner of the multi-tenant apartment home at 117 N Main St, approached my husband in our yard and mentioned that he was interested in potentially clearing some sort of path between N Main St and Rodgers Rd. My husband informed him this was not a possibility.

Days later we now see that Mr. Azah fully cleared the landlocked wooded area right up to our property line—did not leave a single natural boundary, what used to be a nice closed off clearing for us is now a completely open connection to N Main St with visibility to our property from that road.

We are concerned at these developments and would like to learn about Mr. Azah's intentions for this area. We understand that he also operates a 24-hour public coin laundromat in the multi-tenant home which does not make this any more comforting. We now have security concerns that we never had to think about.
